Structure, Governance and Management

Governing Document

Neuro Central is a Scottish Charitable Incorporated Organisation (SCIO) which is governed by its constitution. The Charity was registered with the Office of the Scottish Charity Regulator (OSCR) on 16th June 2016.



Appointment of Trustees

The Trustees of Neuro Central are elected by the organisation's members annually at the AGM. Membership of the organisation is open to any person with a neurological condition living in Scotland, their carers, and friends who are interested in helping the group achieve its aims and objectives. The constitution allows for a minimum of three and a maximum of eleven Trustees.

Organisational Structure

The structure of the organisation consists of:

The members who have the right to attend members' meetings and have important powers under the constitution. The members appoint people to serve on the board and take decisions on changes to the constitution itself.

The board hold regular meetings and are responsible for the strategic direction and governance of the charity. There are no paid members of staff. The Trustees are particularly aware of their responsibilities and adhere to their policies and procedures.

Objects and Activities

The charitable purposes are to advance the health of people living with conditions such as but not exclusive to Multiple Sclerosis (MS), Transverse Myelitis (TM), Parkinson's Disease, Epilepsy, Alzheimer's Disease, Motor Neurone Disease (MND), Acute Disseminated Encephalomyelitis (ADEM), Devic's Disease, Myalgic Encephalomyelitis (ME), Cerebral Palsy, Stroke, Guillain Barre Syndrome, Muscular Dystrophy, Myasthenia Gravis, Spina Bifida, Spinal injuries and Spinal tumours.

The charity provides a complete wellbeing programme offering complementary therapies such as Massage, Reflexology, Reiki and Relaxation, as well as Exercise, Counselling, Physiotherapy and Hypnotherapy.

Achievements and Performances

Interest in Neuro Central continues to grow through this Pandemic, with us now having 224 Facebook members, that's 24 more people interested in NC over the last year. Our Instagram account has also grown from 140 people following to 183.

During summer 2019 we ran an 8 week Mark Making & Print Techniques ran by Tayside Healthcare Arts Trust.

Our members took part in Samba Drumming Workshops delivered by Big Groove Promotions, and played at the Christmas in the Community at the Ayton Hall in Auchterarder.

Neuro Central members were again able to come together and celebrate a Christmas lunch thanks to the generosity of Waitrose, and the Auchterarder Community Bus who provided transport to the venue.

In early 2020 we ran a Pilot Acupuncture study.

In April at the start of the Covid 19 Lockdown one of our members organised a group called 'Sewing Saints'. They made much needed Scrubs for the Doctors and Nurses at St. Margaret's in Auchterarder, The Childrens Hospices Across Scotland (CHAS) in Kinross and Kippen Nursing Home. These were funded by the Co-op fund. Many thanks to all our volunteers and organisers.

Neuro Central continues to meet despite the global pandemic via Zoom

Our research tells us that our Neuro Central meetings are vital for our members to connect up with others who are affected by neurological conditions. When we found out that it was no longer possible for our members to meet safely face to face, we moved Neuro Central online using Zoom, the online meeting platform. Members are informed about upcoming meetings and topics via our Facebook page and email.

While we can't replicate everything we offer at our regular sessions, Zoom has provided an opportunity to at least maintain contact with some of our members and even offer additional sessions, including a Qi gong course, weekly relaxation session and the Neuro Physio activity sessions all from the comfort of members own homes. We offer monthly Neuro Central sessions both daytime and evening and have been able to invite a number of experts to give advice while we were unable to get services during lockdown. These included advice on: Podiatry from Claire Hamilton McPhee; Monthly Mindfulness from Adrienne Hannah; Oral health from Rebecca Valente; Dietary information from NHS Tayside; Counselling from Harriet Hay; Hypnotherapy (including demonstration) from Scott Montgomery and Acupressure from Katherine Dandridge.

Unfortunately, while using technology doesn't suit everyone and can be challenging, a number of our members tell us they really value the continued support from Neuro Central. We also offer help to access Zoom and communicate via telephone and email for those who are not on our Facebook group.

FINANCIAL REVIEW

Fund Raising

Fundraising events for the year included a Supper Club which raised £275 and a Mystery Entertainment Night which raised £400.

Total income from fundraising events and raffles for the year amounted to £1,903.28 which included £127 sponsorship from a previous fundraiser.

We received:

- £676.28 from the Friends of St. Margaret's in Auchterarder
- £321.06 from St. Ninians Round Table
- £200 from Aberfoyle Dance
- £100 from the Transverse Myelitis Group.

We received fund matching from Bank of Scotland of £81.50.

It has been a successful year for grant funding with income of £5550 from Perth and Kinross Community Investment Fund, SCVO and Corra/Gov.

We received £910.02 from the Co-op in Auchterarder.

Reserves Policy

Reserves at the end of the year are £19,149.41 (2019: £28,570). The Trustees believe that £3,000 reserves are ample to allow for the timing difference between receipt and payment. The Trustees have met their target within the current financial year and will use the surplus funds to continue their activities within the current year.

FUTURE PLANS

For the time being we will continue providing our sessions via the Zoom platform due to the Covid-19 virus. We see this continuing until the end of our sessions in June 2021 and hope to return to our normal sessions in September 2021. The monthly Zoom sessions will be held as before, on a Monday morning and Wednesday evening. We plan to continue our monthly Mindfulness sessions as well as our weekly Relaxation and Neuro Physiotherapy Exercise sessions via Zoom. Our Counselling and Hypnotherapy sessions are available in this way at present.

We are also offering an Acupressure Pilot in January 2021 via Zoom.

We are investigating running a 'Living Well with a long-term Neurological Condition' course with support from neurological specialist nurses/OTs and physiotherapists.

Independent Examiner's Report to the Trustees of Neuro Central

I report on the accounts of the charity for the year ended June 30th 2020, which are set out on pages 8 to 13.

1. Basis of preparation
